Direct Sponsor	20%	20%	20%	20%

This bonus distributes 20% according to the BV of the first purchase of the independent seller until completing the master membership (600 BV).



This 20% is distributed as follows, 50% for the sponsor and 50% for You.

This bonus is paid from your first generation and second generation.

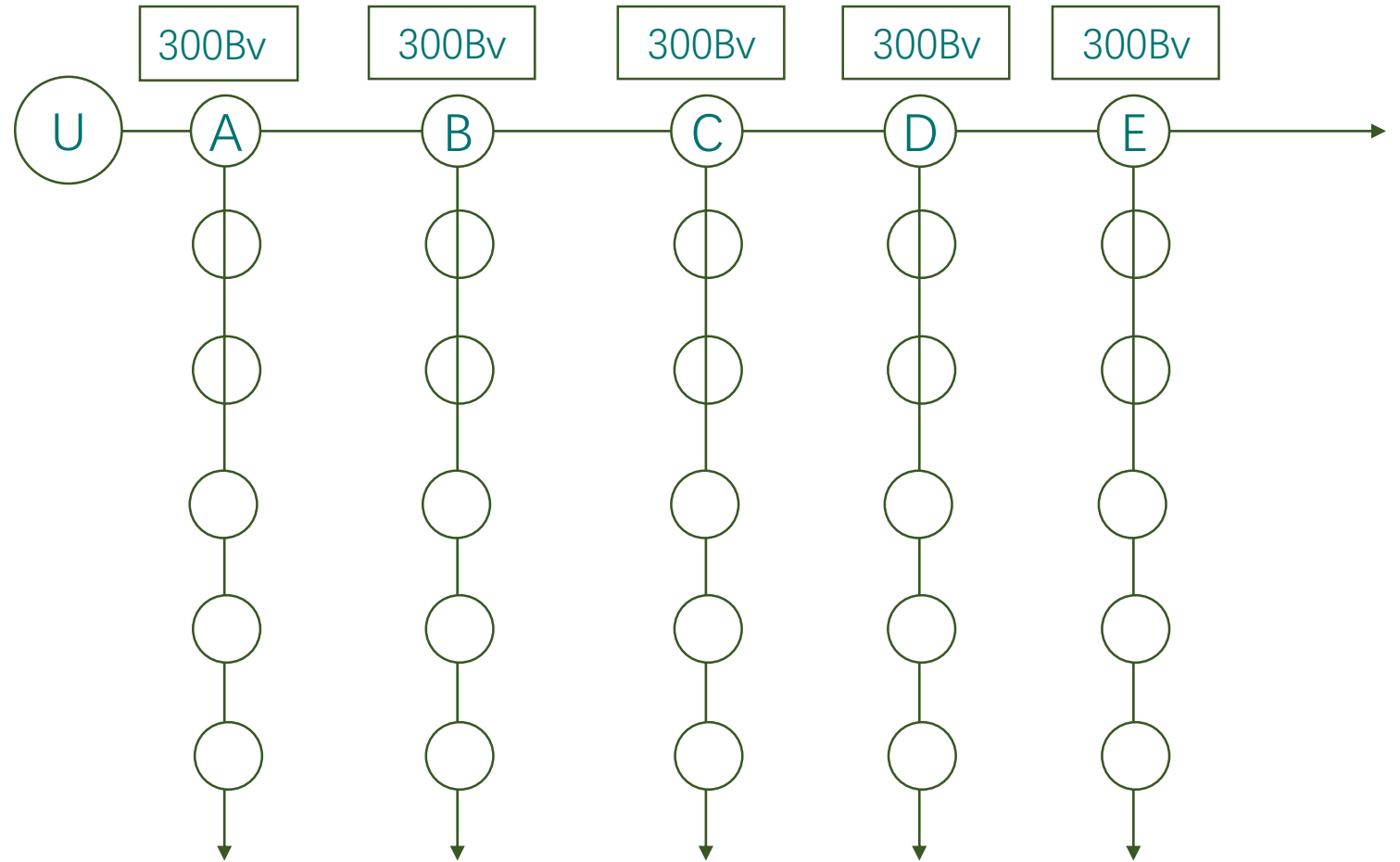

# 3 PAIRING BONUS

 The lowest accumulated BV line is taken as the basis for calculating the bonus.

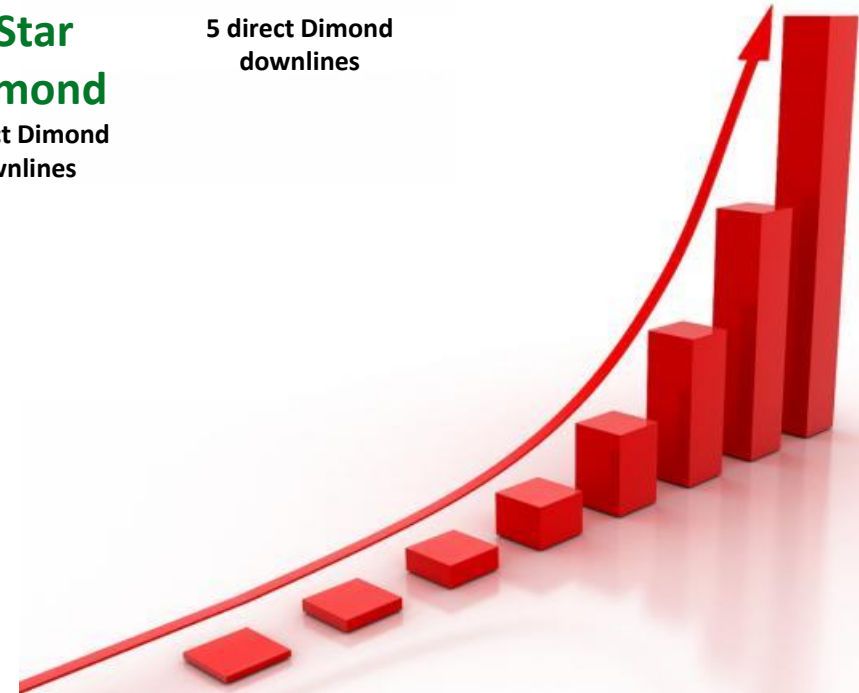
